## PHARMAC parallel assessment of cancer medicines

As of 1 January 2020, suppliers can apply to PHARMAC for funding of cancer medicines with an indication for a cancer treatment, or prevention of cancer recurrence at the same time the medicines are being assessed for regulatory approval by Medsafe.

Previously PHARMAC has not begun the medicine funding assessment process prior to the medicine being Medsafe-registered.

It is predicted that this parallel assessment process will reduce the overall time from submission to Medsafe to ranking by PHARMAC by between 12 to 15 months.
